keynote speaker 1

My Life in Valuation: What's Changed, What Hasn't, and What's Next?

With a unique view shaped by public service and technical rigour, this talk offers valuable insights for anyone interested in the real-world impact of valuation decisions. It's a rare chance to hear directly from one of the UK's most experienced figures in the field.



Steve Thomas
HMRC

Steve Thomas retired from HMRC in September 2025 following a distinguished 40-year career in public service. He began his professional journey in 1985 with the Inland Revenue, initially serving as an HM Inspector of Taxes before joining Shares and Assets Valuation (SAV) in 1992.

Over the decades, Steve played a leading role in several specialist areas within SAV, including the Intellectual Property Team. His final position was as Assistant Director, where he led the Litigation Team and provided oversight to some of the office's most senior valuation professionals. He has acted as an expert witness in a wide range of valuation matters and represented HMRC in several high-profile and technically complex policy areas.

Steve was among the first SAV valuers to qualify as a full Member of the Royal Institution of Chartered Surveyors (RICS), completing the Assessment of Professional Competence in the Valuation of Businesses and Intangible Assets. His work extended beyond HMRC, advising both regulatory bodies and international tax administrations on valuation-related issues, and regularly speaking at industry conferences and seminars.

Outside of valuation, Steve is a passionate football supporter and can often be heard as a regular pundit on the Cardiff City Phone In on Monday evenings during the season.

The Power of Brand in a Shifting Economy: Valuation, Risk, and Opportunity

David Haigh, founder and CEO of Brand Finance, shares insights on the growing role of brand in an economy defined by volatility and change. He will explore how brand value influences business performance, how it can be measured, and why it has become critical to both risk management and strategic planning. This talk offers a timely perspective on the expanding role of intangible assets in valuation.

David Haigh is the Chairman of Brand Finance Plc – the world's leading brand valuation consultancy. He has worked in the area of branded business, brand, and intangible asset valuation since 1991. He specialised entirely in the field after becoming the Director of Brand Valuation for Interbrand in 1995. He subsequently left Interbrand in 1996 to launch Brand Finance which is celebrating 25 years in business this year. David represented the British Standards Institution in the working parties responsible for crafting international industry standards: ISO 10668 on Brand Valuation in 2010 and ISO 20671 on Brand Evaluation in 2019. David is a passionate writer and has authored many articles on brand valuation, published in numerous marketing and finance newspapers and magazines, such as: Financial Times, Accountancy Age, and Marketing Week. He has also lectured on the topic of brand valuation for Harvard, Chicago, and London Business Schools. David graduated from Bristol University with an English degree, qualified as a Chartered Accountant with Price Waterhouse in London, and obtained a postgraduate diploma in Marketing from the Chartered Institute of Marketing (CIM). He is a Fellow of The Royal Institution of Chartered Surveyors (RICS) and has a practising certificate with the Institute of Chartered Accountants in England and Wales (ICAEW).

Before working at IVSC Nick was a global director at RICS and has held various non-executive roles, having previously worked for much of his career in a variety of international roles at Ernst & Young and KPMG.
